- Posted on social media as a reference tool for accessing purebred dogs in the provinces listed.

The listed signatory must:

- Be a current Canadian Kennel Club (CKC) member in good standing;
- Be a current legal resident of Nova Scotia or Newfoundland/Labrador;
- Be in conformity with the CKC Code of Ethics and Code of Practice for CKC purebred member breeders;
- Register all purebred puppies; and
- Pay an annual listing fee of \$20.00 Canadian (renewable December 30) to the HKC. * These funds shall be allocated to the HKC/DKC canine fund. They shall be distributed as designated by the Breeders' Committee or equal representation from each club to a selected charity/s.
